NOTICE

All research scholars registered till year 2016 are hereby intimated that RDC is scheduled from 12th Sep 2019 as per time table published on website. Scholars are, therefore, required to get their work assessed and progress report signed by his/her supervisor. The list of supervisors is also published on website. The supervisors who are not in list but scholar prefers to adopt him/her as supervisor then the supervisor should fulfil the conditions as specified here, which is as per Ordinance of the University. The supervisors as per University Ordinance should have the following criteria, even if they are selected earlier by a scholar. Other than list and with following criteria no supervisor is allowed to guide the scholars of this University. If any scholar has completed two RDC and name of supervisor is in the list published then supervisor will not be changed (if he meets the guidelines as per Ordinance), even if he/she is not part of UTU currently.

- 1. Supervisor should be from same stream as per candidate's BOS or as approved by the RDC given in separate list of supervisors.
- 2. Post Ph.D. 4 years' experience is mandatory for becoming supervisor. Only regular faculty in constituent/affiliated colleges of Uttarakhand Technical University shall be the supervisor of the candidate.
- 3. The supervisor shall not have, at any given point of time, more than eight Ph.D. scholars. However, a supervisor shall not be allotted more than three research scholars in one academic year.
- 4. The supervisor(s) of the candidate shall be finally approved by the University.
- 5. In case a change of Supervisor is required, the research scholar may submit a written request to the UTU citing valid reasons. The change shall be subjected to the approval from the University and having NOC from previous supervisor. Similarly, additional cosupervisor can be added following the procedure.
- 6. Without signature of supervisor who has been assigned and is in the list of supervisor, a scholar will not be allowed to appear in the RDC.
- 7. Scholars who have published the paper(s) in SCI journals should bring first page of published paper(s) as a proof of his/her publication.
- 8. For submission of Ph.D. Thesis, the following are mandatory requirements:
 - a. has completed at least 3 years of research work,
 - b. has completed assigned course work,
 - c. has submitted migration certificate to the University,
 - d. has published 2 papers in SCI journals,
 - e. Submitting satisfactory work certificate from the supervisor and having 200 days attendance with supervisor or with co-supervisor, if permitted by the supervisor.
- 9. If candidate worked for more than 18 months with eligible supervisor he need not take additional/new supervisor even if supervisor has moved out of the UTU or its colleges.
- 10. Supervisor(s) may be allotted to the candidate at his / her request but supervisor will not be changed after completion of 4 years from the date of registration.
- 11. If otherwise suitable, a retired faculty will be eligible to supervise a Ph.D candidate.
- 12. Scholar will solely be responsible if there is any discrepancy in the terms and conditions. University will act as per PhD. Ordinance.
